Definitions

Contract

An agreement with a single vendor, which consists pre-negotiated pricing, terms and conditions for the purchase of specific goods/services contracts must be reviewed by the College's General Counsel and/or Risk Manager prior to signature by an authorized representative.

Standards of Conduct

No College employee, officer or ægnt may participate in the selection, award, or administration of a contract if he or she has a real or apparent condition of interest. Such a ordict of interest would

- A clear and accurate description of thechnical requirements for the material, product or service to be procured. In competitive procurements, such a description shall not contain features which unduly restrict competition.
- o Requirements which the bidder/offeror must fulfill and all other factors to be used in evaluating bids or proposals.

Contracting with small and minority businesses, women's business enterprises, and labor surplus area firms – Federally Sponsored Projects

- a. The College must take all nessary affirmative steps to assæ that minority businesses, women's business enterprisesand labor surplus area firms are used when possible.
- b. Affirmative steps must include:
 - Placing qualified small and minority business and women's business enterprises on solicitation lists:
 - b. Assuring that small and minority businesse, and women's business enterprises are solicited whenever they are potential sources;
 - c. Dividing total requirements, when economically feasible, into smaller tasks or quantities to permit maximum participation by small and minority business, and women's business enterprises;
 - d. Using the services and assistance, as appropriate, of such organizations as the Small Business Administration and the Minority Business Development Agency of the Department of Commerce.

Procurement records – Federally Sponsored Projects

Procurement records and files, fopurchases made using either the Procurement by small purchase procedures or Procurement by sealed bids, include following at a minimum: 1) the solicitation / request for bid, 2) the vendor proposals or quotes) basis for contractor selection, 4) justification for lack of competition when competitive bids or offers are not obtained as described above, and 5) basis for award cost or price. Acopy of these records shall be matained by the Office of Grants and Contracts in the related award file.

Receipt of Goods Acknowledgment

Principal Investigators are responsible for verifying the actual receipt of goods and services. Receipt of acknowledgment confirms that purchase **g**oods and services have been received in the manner and quantity ordered and completed when the authorized signer initials the invoice approving payment.
