Occidental's Sexual Misconduct Policy prohibits all forms of sexual or gender-based harassment,

WHAT TO DO IF YOU EXPERIENCE SEXUAL HARASSMENT, SEXUAL ASSAULT, INTIMATE PARTNER VIOLENCE, OR STALKING

1 Get to a safe place – any place where you feel safe and secure. If you are in a vehicle, pull over to a safe location. If you are on a campus, go to a safe place such as a residence hall, library, or student center. If you are off campus, go to a safe place such as a police station, fire station, or a friend's home. If you are in a public place, go to a safe place such as a store, restaurant, or public building. If you are in a private place, go to a safe place such as a friend's home or a safe house. If you are in a vehicle, pull over to a safe location. If you are on a campus, go to a safe place such as a residence hall, library, or student center. If you are off campus, go to a safe place such as a police station, fire station, or a friend's home. If you are in a public place, go to a safe place such as a store, restaurant, or public building. 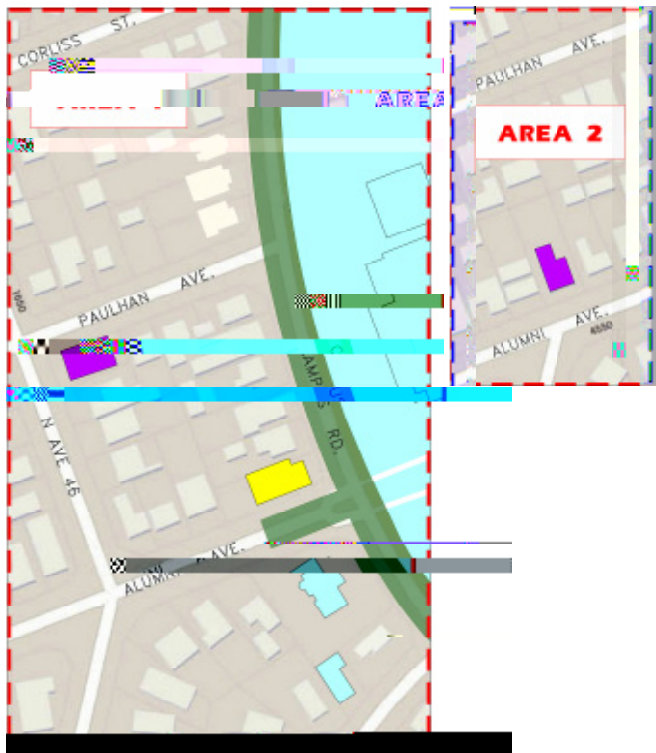
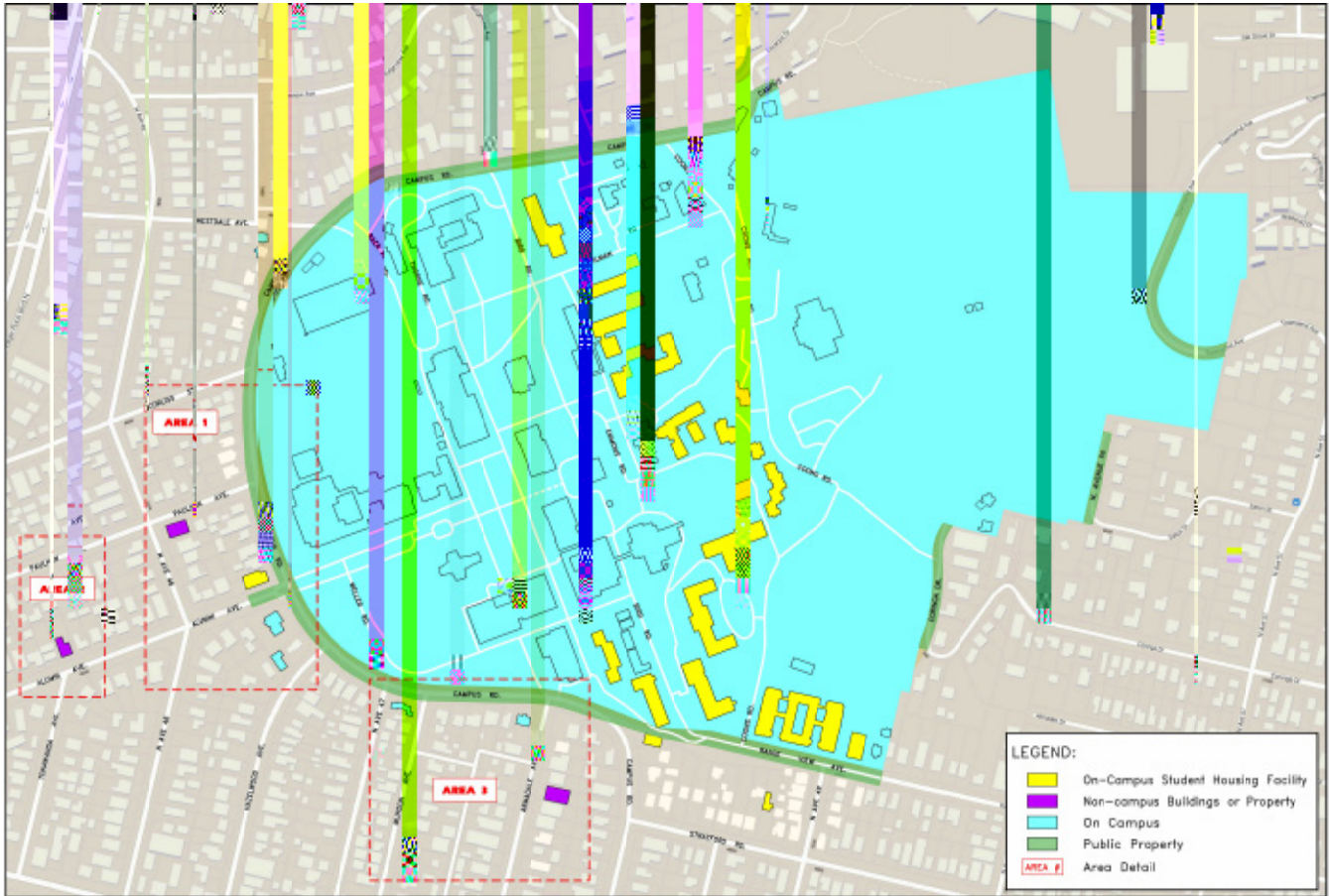
